





## Proposal to ISO: Trustlist method that separates inbound and outbound

- -Inbound: A pointer to DTL which is a list of trust services recognized in the jurisdiction
- -Outbound: A list of pointers to inbound TL (LoTL) of counterparty countries mutually Recognized by the TL (LoTL) issuing country under a treaty between countries or regions
