

# KSA Digital Signature Early Days & Regulatory Milestones

2001

The National Center for Digital Certification (NCDC) was founded to govern digital certificates and PKI.

2007

The **Saudi Electronic Transactions Law** was enacted, which formally established **NCDC** as the national authority responsible for overseeing digital certification and trust services.

2010

Saudi National Root CA was created & operated by NCDC.

The NCDC was also moved to be under the Communications and Information Technology Commission

2016

Saudi Arabia Vision 2030 Announced

2019

The **Saudi Electronic Transactions Law** was approved to recognize the legality of digital signatures It is aligned with global practices like **WebTrust**.

2021

CITC restructured as the Digital Government Authority (DGA)

2024

DGA has licensed an additional 8 comprehensive TSPs & 5 Limited TSPs

# PKI Hierarchy in KSA














