What is the EU Digital COVID Certificate?

An EU Digital COVID Certificate is a digital proof that a person has either

- ✓ been vaccinated against COVID-19
- ✓ received a negative test result or
- ✓ recovered from COVID-19

National authorities are in charge of issuing the certificate. It could, for example, be issued by test centres or health authorities, or directly via an eHealth portal.

- ✓ Vaccination certificates are issued by the Member State where the vaccination has been administered.
- ✓ Test certificates are issued by the Member State where the test has taken place.
- ✓ Recovery certificates are issued by the Member State where the recovered person is located.




Apply for EU DCC mechanism-compatible records

Members of public in Hong Kong who hold valid local vaccination / testing / recovery records can download relevant records from the COVID-19 Electronic Vaccination and Testing Record System (eVT System) or through the "iAM Smart" mobile application. In order to authenticate the user's identity, the user has to enter personal information such as Hong Kong Identity Card number, passport number and other data required by the system. As an alternative, members of public can also download the relevant records via iAM Smart. Besides, the certificate can be downloaded in PDF format and printed out for travel purposes.

The records contain necessary information such as name, date of birth and your local vaccination / testing / recovery records. Besides, the records also include a unique digital identifier as well as a digital signature to ensure that the records are authentic.




The Launch of EU Digital COVID Certificate in Hong Kong





How to download the COVID-19 Electronic Vaccination and Testing Record with iAM Smart



- 1. Login to the "iAM Smart" in your mobile device. If you have not installed and registered to use "iAM Smart", please refer to the thematic website of "iAM Smart" to download and register to use "iAM Smart".
- 2. Choose "COVID-19 Electronic Vaccination and Testing Record" service.





How to download EU Digital COVID Certificate via iAM Smart mobile App

1. Login iAM Smart and click "COVID-19 Electronic Vaccination and Testing Record System" . Then follow the on-screen instructions for retrieving personal data from iAM Smart for subsequent certificate generation.





- 2. After the "COVID-19 Electronic Vaccination and Testing Record System" page is shown, scroll down the screen and click the "EU Digital COVID Certificate" button.
- 3. When the menu of "EU Digital COVID Certificate" is shown, click the desired button to download the corresponding certificate. The following used "EUDCC Vaccination Certificate" as an example for illustration.





- 4. Corresponding "EU Digital COVID Certificate" screen is shown if there is a valid record.
- 5. Scroll down to the bottom to download the PDF certificate by clicking the "Download PDF" button.
